

Lafayette Band Association 2019-20 Payment Agreement for Concert and Marching Band

Please complete and sign this payment agreement to reserve your place in the 2019-20 Lafayette Concert or Marching Band. **This agreement should be returned with the first month's payment by March 15, 2019.** The Concert and Marching band payments for this year are \$300 or \$1,200, respectively. There are 2 payment schedules for marching band available for your convenience. Sibling payments are for the second (or more) student(s) when 2 (or more) siblings are currently in marching band.

Please note that even if you do not return the Payment Agreement, your student's participation obligates you to the payment.

- \$1,000 for the Early Payment Schedule (\$200 discount)* – must be **paid in full prior to May 15, 2019.**
- \$1,200 for the Standard Payment Schedule – must be paid in full by August 15, 2019.
- \$500 for the Sibling Early Payment – must be **paid in full prior to May 15, 2019.** *(The first student in a family must be paid in full before a family can realize any Sibling Early Payment discount(s).)*
- \$600 for the Sibling Standard Payment – must be paid in full by August 15, 2019.
- \$300 for the Concert Only Payment – must be paid in full by December 15, 2019.
- My student qualifies for the Free Lunch Program. I understand I must contact Mr. Smith at chuck.smith@fayette.kyschools.us or 859-396-3311 by March 15, 2019 to verify and provide a copy of the Notice of Approval received from the Child Nutrition Office for the 2019-20 school year. *(Once documentation is provided I understand the fees outlined in this payment agreement will be waived. If I do not provide documentation I understand that I am responsible for the fees outlined in this payment agreement.)*
- My student qualifies for the Reduced Lunch Program. I understand I must contact Mr. Smith at chuck.smith@fayette.kyschools.us or 859-396-3311 by March 15, 2019 to verify and provide a copy of the Notice of Approval received from the Child Nutrition Office for the 2019-20 school year. *(Once documentation is provided I understand I am responsible for HALF the fees outlined above for each of my students. (Early Payment, \$500 for one student (+\$250/sibling); Standard Payment, \$600 for one student (+300/sibling)). If I do not provide documentation I understand that I am responsible for the fees outlined in this payment agreement.)*

**Early Payment Schedule Discount available only if current account balance is \$0 since payments are applied to the oldest debt first*

- Standard Payment Schedule - \$1,200 Must be paid in full by August 15, 2019**
